4. The Client hereby waives its rights to receive a financing or verification statement relating to the registration of any security interests granted herein.
5. Mainland Floral retains legal and beneficial title to all good supplied to the Client until such goods have been paid for in full.
6. The Client shall be liable to Mainland Floral for all costs incurred by Mainland Floral in collecting overdue accounts from the Client.
